Payment Deadline

In exchange for payment in full for the exhibit space contracted by the Exhibitor, TNS will provide exhibit space as outlined in the Exhibitor Regulations. For the Winter Conference, payment in full is due by January 9, 2024 and for the Summer Conference, July 5, 2024. It is not necessary to send payment with this application form, but payment must be received by the established deadline(s).

Qualifications of an Exhibitor:

TNS show management will, in its sole discretion, determine whether a prospective Exhibitor is eligible to participate in the TNS show(s). Exhibitors shall be limited to those whose products or services are related to neurology, medical, professional, or practice interests. The TNS reserves the right to refuse to provide exhibit space to any Exhibitor not compatible with the general character and objectives of the TNS show(s), or if the TNS show(s) is full upon receipt of the application.

Cancellation Deadline:

A full refund will be made to the exhibitor only if written notice is received by January 5, 2024 for the Winter Conference and July 3, 2024 for the Summer Conference.

If, after the contract is entered into, the TNS fails or is unable to provide an Exhibitor with the opportunity to exhibit at the TNS show(s), due to fire, strikes, authority of the law, act of God or any other cause or reason, and the Exhibitor is not responsible for such failure, the Exhibitor's sole and exclusive remedy shall be the return of all monies that it has paid in connection with the Application/Contract. In such case, the TNS shall bear no further liability or responsibility under such agreement.
